The International Sculpture Center Welcomes New Board Member, Connie Wimer.

The International Sculpture Center (ISC), a global nonprofit arts service organization, announced the addition of Connie Wimer to the ISC Board of Trustees.

Connie Wimer has built a long and fascinating career in business and publishing. An Iowa native, Ms. Wimer was the owner and president of Iowa Title Company from 1976 to 1985 when she sold the company to Amerus. She maintained her position of president of the company until 2001. Ms. Wimer was the first woman chair to the Des Moines Chamber Federation, the first woman to serve as chair of the National Alliance of Area Business Publications, and she is the first woman to receive the Alliance's Lewis M. Conn Award for outstanding contributions to the business publications industry. She has received a myriad of awards including the 1991 Young Women's Resource Center "Visionary Women" Award, Master Editor/Publisher by the Iowa Newspaper Association in 2006, and the Association of Fundraising Professional's Outstanding Volunteer Fundraiser Award in 2007

Robert Duncan says of Wimer, "Connie is a remarkable woman who has built her own business; she is experienced in publishing and has recently started a new advisory branch to her publications business. She is not only successful and a great business woman, she is generous with her time and would love to serve on the board of the ISC."
